1.0. CALL TO ORDER / ROLL CALL

The meeting was called to order by Chairman Makio at 3:13 p.m. and roll call was conducted.

APPROVAL OF MINUTES (November 27, 2019 Meeting) 2.0.

Motion

Chairman Makio opened the floor for discussion on the minutes of November 27, 2019. With no changes or amendments a motion was made by Dave Lotz to approve the minutes as read. The motion was seconded by Eric Forbes and unanimously approved.

#### 3.0. **ELECTION OF OFFICERS**

Chairman Makio opened the floor for nominations for Vice Chair, Secretary, and Treasurer of the Board of Directors.

#### 3.1 Vice - Chair

Eric Forbes nominated Dave Lotz for Vice Chair.

No further nominations were made. Dave Lotz accepted the nomination.

#### 3.2. Secretary

Nicole Calvo nominated David Atienza for Board Secretary.

No further nominations were made. David Atienza accepted the nomination.

#### 3.3. Treasurer

Eric Forbes nominated Nicole Calvo for Board Treasurer.

No further nominations were made. Nicole Calvo accepted the nomination.

Chairman Makio closed the nominations for Board Vice-Chair, Secretary, and Treasurer then

called for vote to approve the nominations by a show of hands.

Motion

Eric Forbes motioned to update the bank signatory cards to reflect the changes of the Board

Officers and new members.

Nicole Calvo seconded the motion. With no objections or discussion the motion was unanimously

approved.

#### 4.0. EXECUTIVE SESSION

Chairman Makio recessed the Regular Board meeting and entered into Executive Session. Executive Session adjourned and the Regular Board meeting resumed at 3:35 p.m.

#### 5.0. OLD BUSINESS

#### 5.1. Marianas Islands Training and Testing (MITT)

Chairman Makio presented an update from a meeting held in December with Senator Therese Terlaje.

SHPO Patrick Lujan updated on a subsequent meeting held with the military and the office of the Attorney General. Updates will be presented through public meetings in the northern, southern, and central areas.

GPT will assist the SHPO and the Guam Buildup office to coordinate the public meetings.

The Board discussed conducting a basic Section 106 course through a mini-series workshop. In the past GPT had engaged with ACHP and offered Section 106 training.

#### Motion

There being no further discussion Dave Lotz motioned to authorize \$7,000.00 for GPT to engage the appropriate service to offer Section 106 essentials training primarily geared toward the Guam community and that subsequently the GPT annual budget include a line item for Section 106 training.

Nicole Calvo seconded the motion and with no further discussion was unanimously approved.

#### 5.2. Atantano Heritage Preserve Planning Update

Joe Quinata reported the staff is working on submitting a grant with the National Trust for Historic Preservation to continue outreach programs for the Atantano property similar to the Take Care Grant program which resulted in creating a trail to a cultural research site. Staff requested an ad hoc committee be formed to review the recommendation for the use of the property.

Chairman Makio invited any interested Board members to participate in the ad hoc committee.

#### 5.3. Historic Preservation Course

Joe Quinata reported Okkodo High School has implemented historic preservation in vernacular architecture as part of their pre-engineering class and offers an introductory.class in historic preservation.

The University of Guam offers a course in heritage preservation under the instruction of Dr. Bill Jeffery who conducts lectures and fieldwork under the College of Liberal Arts & Social Sciences. UOG's Intro to Engineering course includes the study of the completed engineering plans contracted by GPT for the Taleyfak Bridge, Antonio Chargualaf, and Juan Flores homes.

#### 6.0. NEW BUSINESS

#### 6.1. GPT Legal Counsel Proposal, Evaluation, and Recommendation

Chairman Makio and Joe Quinata had conducted interviews with the two legal proposals received in response to the RFP.

Proposals were received from the firm of Brooks Concepcion LLC and the second from Attorney Vanessa Williams.

Joe Quinata reported the proposals were sent to all Board members to review and rate. Attorney Vanessa Williams received the highest rating by the Board.

The Board discussed the final process of negotiation of fees has yet to be conducted. Joe Quinata reported if the attorney fees from the highest rated firm are not acceptable, negotiations will continue with the second firm.

Nicole Calvo recommended staff to attend off-island events instead of Board members.

- Application must fall within the categories specified by the Guam Preservation Trust (GPT) Programs and the FOCUS projects of the Fiscal Year. See "Circular 2020-A"
- Proposed activities should take place entirely or substantially within the Territory of Guam.
- Applicants should concentrate their grant proposals on topics related specifically to Guam.
- Grant Applications should be completed in full, regardless of the scope or the amount budgeted.
- Proposed projects must demonstrate a clear commitment to authenticity and preservation.
- Grant projects must be balanced and non-partisan.
- GPT requires a cost-share by each grantee either in cash or in-kind contributions for the grant proposal.

#### WHO MAY APPLY

- Applicants may be individuals, community organizations or societies, community galleries or museums, religious or faith based organizations, humanities councils, registered nonprofit organizations, ethnic clubs, festival sponsors/organizers, or educational institutions.
- Individual Applicants must be U.S. citizens and residents of Guam. Individual applications who do not meet the above criteria may affiliate themselves recognized Guam-based organizations for Sponsorships.
- Government entities may apply. However, such grant applications are governed by Public Laws 20-151, 21-07 and 27-89, which prevent the use of GPT funds for operational expenses.

#### **BUDGET GUIDELINES**

- 1. Budgets must be submitted on separate sheets of paper. The heading: "(Name of the Grant Project)
  Budget" must be at the top of the page.

**Duration of Project: January 2020 – July 2020** 

#### a. Project Goals

- i. GOAL #1: Participants will have a greater understanding of an historical event or a series of events in Guam's history and be able to explain the importance of and the resulting impact of these events in Guam's history in public presentations (GPT Strategic Initiative: Capacity Building)
- ii. GOAL #2: Participants will know how to engage in library/archival research, oral history collection, fieldwork, or other research methods in order to understand an historical or a series of events in Guam's past (GPT Strategic Initiative: Capacity Building; GPT Initiative Education and Outreach; GPT Resources, Technology, Research and Development.)
- iii. GOAL #3: Participants will be able to prepare an interpretive presentation of an historic event or pattern of events for public display in a variety of formats (GPT Strategic Initiative: Capacity Building; GPT Initiative Education and Outreach; GPT Resources, Technology, Research and Development.)

#### b. Project Objectives

- i. Objective #1: Approximately 400 secondary students will have engaged in library and archival research and conducted oral history collection related to specific events and/or locations significant to Guam's history as a part of the Guam History Day Competition.
- ii. Objective #2: Approximately 90 secondary students will have prepared and delivered a presentation in one of five formats that explains, expresses, and/or interprets specific historic events and/or broad patterns of events significant to Guam's history (GPT Goal II: Public Interpretation and Presentation) at an islandwide Guam History Day competition on March 23, 2020.
- iii. Objective #3: At least 8 secondary students and their teacher advisors will have prepared and delivered a presentation at the National History Day competition in University of Maryland.
- iv. Objective #4: At least 8 secondary students and their teacher advisors will have met with local officials who are responsible for the protection and preservation of historic resources in Guam and with federal officials who are engaged in policy making that impacts historic preservation and conservation in Guam and the region.

#### c. Expected Outcomes of Project:

Participants will have experienced the importance of historical preservation from the following perspectives: History as Research, History as Education, History in Public Exhibition, History in Public Policy, and History as Community Identity.

#### d. Project Location

Guam; College Park, Maryland (National History Day); Washington DC

#### e. Introduction/Summary of Proposed Project

The limited exposure that Guam's youth currently have to Guam's history reduces their understanding of the historical events that have shaped this island and its communities; thereby, making them less able to make informed decisions and policy related to the preservation of resources that are significant to the island's history. This project serves to promote historical research on Guam History through two competitions and to a select group of students with experiences that will heighten their awareness of how research is conducted, how it informs public interpretation of historical events, and how it is used to shape public policy.

#### II. NEED FOR ASSISTANCE

#### a. Need for Assistance

Successful historic preservation requires an informed community, one that is knowledgeable about the historical events that occurred within their community and how these events shaped and/or changed public policy, social norms, as well as their physical and lived environments. At present, Guam does not have a robust Guam history curriculum. In fact, Guam's public school system requires one Guam history course at the secondary level (middle or high school) and not all of Guam's private schools require even a semester of Guam history. This scenario leaves the island vulnerable to a citizenry who is unfamiliar with the events that have created the island's community and historical significance behind various physical structures and island landmarks, thereby making successful historic preservation a challenge.

This project helps to promote an informed young citizenry by encouraging secondary students to engage in research into a topic of Guam's history of their own choosing and to extend that research experience by seeing the different ways historical research is carried out and can be used to inform a variety of audiences.

The financial need for assistance of this project is for \$27,000 which represents 30% of the total cost to run this program in its entirety; the expenses are related to participation in the National History Day competition, including:

- Costs related to approximately 10 students, their teacher chaperones, and the Guam History Day Coordinator (MARC) to attend the National History Day competition in University of Maryland College Park
- Registration for National History Day
- Competition medals, certificates, and other incidentals needed for running the islandwide competition
- Creation of logo design related to the Guam representatives at National History Day

#### b. Applicant's Long-range Goals

MARC's long-term goals related to this project are to:

- Increase public awareness of the historical events that have shaped the island and its communities
- ii. Foster the next generation of researchers who are engaged in the preservation of Guam's historic and cultural resources.
- iii. Give Guam's students the practical research skills needed for college-level research and/or the professions related to the preservation and conservation of Guam's historical and cultural resources.

#### III. PROJECT APPROACH

#### a. Partnership planning

MARC and Guam Preservation Trust work with interested teachers in Guam's public and private secondary schools in providing background information about the analytical theme and the historical research process prior to the beginning of the competition year. MARC and Guam Preservation Trust seek out historians, academicians, educators, librarians and community leaders who serve as mentors to the students as they conduct research. These mentors also serve as sources of feedback for secondary school teachers on which research and composition skills require additional focus and attention as well as feedback to competition organizers on how the themes may be interpreted or addressed in future competitions.

#### b. Implementation plan

September 2019 - January 2020: secondary students at various Guam secondary schools have engaged in research on Guam's historical events and are creating presentations that examine these events through the analytical concept of "Breaking Barriers."

During this period,

- GPT has updated the Guam History Day website to include all pertinent data related to the competition
- MARC has extended its hours to be open on Saturdays (9a-12p) to accommodate student research being conducted.
- Representatives from GPT (Joe Quinata) and MARC (LaVonne Guerrero-Meno, Monique Storie, and/or Victoria-Lola Leon Guerrero) have provided school visits, group and/or one-on-one presentations to students to help them understand the theme and the competition rules, how to engage in research, how to conduct interviews, or how to cite non-traditional archival sources.
- MARC and GPT will recruit historians, academic personnel, educators, librarians, and community leaders to serve as judges for the Guam History Day in January 2020.
- LaVonne Guerrero-Meno (MARC) will secure the rooms and room codes for the islandwide competition in January 2020.

February 2020 – March 2020, students compete at their schools for a berth to present at the islandwide competition, Guam History Day.

#### During this period:

- MARC and GPT will reconfirm which historians, academic personnel, educators, librarians, and community leaders will serve as judges and site volunteers for the Guam History Day in March 2020.
- LaVonne Guerrero-Meno (MARC) will receive the registration forms from the school competition winners and create schedule of competitions.
- LaVonne Guerrero-Meno (MARC) will arrange for certificate of attendance to be completed by March 21, 2020.
- LaVonne Guerrero-Meno (MARC) will arrange for community members to run the judges tabulation program on competition day to ensure impartiality and accuracy of scoring.
- LaVonne Guerrero-Meno (MARC) will arrange for student organizations to volunteer as campus guides on the competition day.
- LaVonne Guerrero-Meno (MARC) will compile a list of post-competition mentors who have expertise in the formats and the periods presented in competition entry titles/subject areas.
- MARC will order medals from the National History Day organization.
- MARC personnel will prepare judges packets and student registration forms for competition day by March 20, 2020.

March 21, 2020: Guam History Day competition.

#### On this day:

- MARC personnel and volunteers will run the registration table and the judges' work room.
- Monique Storie (MARC) and Joe Quinata (GPT) will serve as decision makers related to issues arising during competition.
- LaVonne Guerrero-Meno (MARC) will serve as point of contact regarding needed changes in logistics during competition.
- LaVonne Guerrero-Meno (MARC) will compile the winners who qualify to move forward to National History Day at the University of Maryland: College Park in June 2020.

March 25, 2020-May 31, 2020: Preparation for National History Day competition

#### During this period:

- MARC and GPT representatives will select up to 10 students to represent Guam at the National History Day competition.
- LaVonne Guerrero-Meno (MARC) will inform students (via their instructors) who were selected to compete in Washington DC.
- LaVonne Guerrero-Meno (MARC) will reconfirm the post-competition mentors and create a calendar of NHD mentor workshops.
- GPT will hold an informational seminar for students and their teacher chaperones to provide them with National History Day rules and announce the calendar of NHD student mentorship workshops and public appearances.

#### c. Project Staff Biographies and Position Descriptions

Principal Investigator: LaVonne Guerrero-Meno (MARC) is the Administrative Officer and Outreach Coordinator. Ms. Guerrero-Meno's role in this project is to:

- Plan and run the Guam History Day competition event
- Coordinate the mentorship experiences for those students who are selected for the national competition
- Certify for Guam Preservation Trust those students who are eligible for participation at the National History Day competition
- Create a calendar of events for students at the National History Day
- Coordinate the development of shirts, buttons, and other mementos to be distributed to National History Day peers.
- Coordinate the travel arrangements for selected students and their chaperones to attend and compete at the National History Day.

Ms. Guerrero-Meno has served as MARC's Administrative Officer for over 20 years. In this role, she has successfully administered the financial aspects of federal and local grants. As part of her Outreach Coordinator duties, for approximately 7 years, Ms. Guerrero-Meno has served as the state-level coordinator for the National History Day qualifying event: Guam History Day, where she has planned and executed the Guam History Day event as well as coordinated the logistics for the National History Day activities.

Co-Principal Investigator: Monique Storie is the Dean of University Libraries. Her role within this project is to:

- · Assist the Outreach Coordinator in the planning and execution of the Guam History Day event
- Provide guidance in the research process to students and teachers
- Assist in the interpretation of rules of the Guam History Day event on competition day
- Assist in the determination of eligibility of entries for the Guam History Day and National History Day events
- Assist in the coordination of and serve as a mentor in the post-competition mentorship workshops

Co-Principal Investigator: Joe Quinata (Guam Preservation Trust) is the Executive Director for the Guam Preservation Trust. His roles as former regional coordinator for National History Day and his involvement with historic preservation activities will help to ensure that this project fosters the development of research skills and making transparent the connections between history research and public awareness of history. His role in this project is to:

- Assist in the recruitment of judges and mentors for the Guam History Day event.
- Provide guidance regarding the rules and policies for Guam History Day.

Assist in the creation of a calendar of events at the local and national level that provides
participants with hands-on experiences related to history as research, history as public
exhibition, history as policy, and history as education.

#### V. PROJECT IMPACT AND EVALUATION

#### a. Expected Project Impact

This project has a potential impact of approximately 400 students, their teachers, as well as their school communities. At the widest level (student research phase from September 2019 through February 2020), these students will have explored through research at least one period or event in Guam's history and presenting their findings to their school peers. Some students will have additional exposure to the research, interpretation, and public presentation of Guam's history as they present their findings to a panel of judges (comprised of historians, school teachers, librarians, college professors, civic leaders, and public servants). Some of these students will have the opportunity to experience the various roles of a historian in promoting, educating, and enacting policies related to the preservation of historic resources through their public presentation of their research on Guam; educating and promoting the island's history to their peers (and judges) at the National History Day competition; and experiencing how historical research is presented in national galleries and are addressed by the various federal public servants.

#### b. Evaluation and Monitoring Process

Evaluations (participant judging forms), direct and indirect feedback serve as the main forms of evaluation for this project.

Evaluations: As a part of the National History Day organization, the Guam History Day has a rubric by which all entries are evaluated. Students receive direct feedback on how their research project scored in relation to their peers particularly in terms of the strength of their research, the balancing of historical perspectives, and how clear their analyses and arguments were.

Indirect Feedback: The Guam History Day program uses these score sheets as a way to find the themes related to research skills and persuasive arguments to help the participating secondary school teachers understand their students' ability to conduct research so they can refine their instructional program. The public presentations at the Guam History Day and National History Day events serve as a way to gain informal feedback from the community on how well they understand the research findings. The number of teachers and students who choose to participate in subsequent competitions provide a level of feedback on the usefulness of the program.

Direct feedback: Direct comments from the instructors, judges, and participants after the Guam History Day and National History Day events will serve as another form of evaluation on the effectiveness of this program. These comments are used to refine the program and competition event.

#### **Project Title**

#### Spanish shipwrecks in Guam

#### **Duration of the Project**

March 1, 2020 to March 1, 2021

#### **Project Goals**

The project has a number of goals:

- Highlight the value and potential of Guam's underwater cultural heritage in revealing aspects of its cultural identity;
- Raise the awareness about the need to protect and preserve Guam's underwater cultural heritage;
- Highlight the potential of Spanish shipwreck research (historical and archaeological) in the history of Spanish trade and seafaring, and its association with Guam.

#### **Project Objectives (not activities)**

The project has a number of objectives in working towards these goals:

- Gain a comprehensive understanding of the Spanish shipwreck resource in Guam trough archival work and geographic contextualization;
- Collate and disseminate the Spanish shipwreck data and history for making more informed decisions about the historical and archaeological value of the material.

#### **Expected Outcome(s) of the Project**

The outcomes of the project will include:

- Publication of a c. 100-150 page bilingual book (in Spanish and English) of the archival material and relevant archeological and geographical information;
- Publication of some of the information on websites, social media, including University of Guam, Micronesia Underwater Cultural Heritage, <a href="http://www.micronesiauch.org">http://www.micronesiauch.org</a>;
- Present the results of the work on the Marianas History Conference in March 2021 during the Commemoration of Magellan circumnavigation in Guam.

#### **Project Location**

The project will take place in Spain and Guam.

#### Introduction of the Proposed Project

Spanish vessels started to navigate the Pacific Ocean in 1521 when Magellan crossed the strait that baptized with his name in the southern part of South America. His discovery allowed Span to gain access to the riches of China and Southeast Asia. Several expeditions followed Magellan's footsteps like Loaisa's, Alvaro de Saavedra's, or Mendaña's expedition. Finally, in 1565 Urdaneta, with the galleon San Pedro, reached new Spain coming from the recently claimed Philippines. He discovered a safe way to come back from Manila to Mexico without crossing Portuguese territories —el tornaviaje— and the Spanish crown established the Manila Galleon trade that lasted 250 years.

A Royal Decree made the Mariana Islands a compulsory stop on this trade to support the mission in Guam and was also used to replenish the galleon with fresh provisions and water. The strategical position of the Mariana Islands running perpendicular to the main north equatorial currents made these islands a safe post in the middle of a vast unexplored ocean.

A list of 22 Spanish shipwrecks located in and around Guam's waters has been drawn from six different sources, providing dates for the shipwrecks as from 1552 through to 1829-37 (Appendix 1). None of these shipwreck sites have been identified. There have been unsuccessful attempts to locate the *Neustra del Pilar de Zaragoza* (1690). Two shipwrecks, *Santa Margarita* (1601) and *Nuestra Senora de la Concepcion* (1775) have been discovered in the Commonwealth of the Northern Marianas (CNMI), but no other sites have been discovered.

Some the earlier shipwrecks are documented as Manila Galleons, the full-body timber vessels which sailed between Acapulco and Manila (from 1565 to 1815) with outward cargoes of silver coins and return cargoes of Asian porcelain, jade, jewelry, silk, art works, precious stones and spices. The archaeological remains recovered from the *Santa Margarita* included 300 beautifully carved ivories from China, which are now in a private collection in USA. Similarly, artefacts recovered from *Nuestra Senora* 

de la Concepcion (another treasure hunting operation), included gold objects, that have fortunately found their way into a public museum in Saipan.

An aim of this project is to initiate a project that will lead to better knowledge about the whereabouts of the Spanish shipwrecks in Guam's waters; the types of cargo they were carrying; the potential for implementing archaeological surveys; and consideration of the most effective protection and preservation measurements. Information gathered in the course of this project may include location information that if published, could provide assist treasure hunters in looting the sites. This factor will be considered when developing the publication and other project dissemination. This approach, in gaining as much knowledge about these sites and making it publicly available, which raises an awareness about their historical and archaeological value and the need for further research, preservation and protection, is well-regarded as the most effective management approach, rather than doing nothing and 'hoping' that the sites are not found by treasure hunters. Additionally, the majority of people, particularly the Guam community miss-out of being informed about their history and cultural heritage, if a silent approach is used. It is much better strategy to raise an awareness about the significance of this material, to work collaboratively with agencies such as Guam Preservation Trust and the Guam Historic Preservation Office (HPO) and the US National Park Service (NPS) to manage these sites for the benefit of the Guam and international communities.

#### **Criterion 2: Need for Assistance**

#### **Need for Assistance**

This project covers a diverse range of activities which fall into a number of programs that GPT supports and as outlined in their Grant Application Information, including:

- Historic Property Documentation and Register Nomination
- Public Interpretation and Presentation

#### Applicants' long-range goals

The applicants are from the Anthropology Program, Humanities Division, College of Liberal Arts and Social Sciences.

In 2014, the Anthropology Program reworked their mission and objectives to focus on the Anthropology of the Ocean. Courses such as 'Peoples of the Pacific', 'Cultural Anthropology', 'Research Methods in Anthropology' implemented by Dr. Atienza stimulated this Anthropology of the Ocean approach. This was enhanced through employing maritime archaeologist Dr. Jeffery, who developed and implements a number of new courses, including 'Introduction to Maritime Archaeology', 'Asia-Pacific Maritime Archaeology', and 'Preserving Cultural Heritage'. An advanced archaeological method course has formed the basis for the three field schools implemented since 2015, which have all been maritime related, and implemented in Guam, Yap and Chuuk.

The applicants' long-range plans through the Anthropology Program is committed to teaching and researching maritime anthropology in Guam and the region. It is committed to having local people educated to implement programs that are relevant and beneficial to Guam and the regions' communities.

#### **Criterion 3: Project Approach**

#### Partnership planning (Community involvement in the planning of the project)

Dr. Jeffery and Dr. Atienza are in communication with Dr. Ivan Negeruela, Director of the Museo Nacional de Arquelogía Subacuática and with the Vice-Admiral Ignacio Horaca Rubio from the Naval Museum of Madrid to establish possible collaborations. They have a great interest and willingness to generate teams of work. In developing the publication and promotional material, the project will liaise with the Guam HPO, the USA NPS and other relevant agencies having a role in preserving and protecting underwater historical properties.

For the publication, we will partner with the University of Guam Press.

#### Implementation plan

Phase 1. Archival research (months 1 to 6). The best source of information is the Spanish Archives in Sevilla (Archivo de Indias) and in Madrid (Archivo del Museo Naval and Archivo Nacional de Madrid). Some of these sources might be also available in the MARC in the Spanish Documents Collection. This project, if successful will provide funding for a researcher to implement the historical research and to gather the data in Spain. This researcher will collaborate closely with the project applicant's that will monitor the research in Spain and match it in MARC if there were pertinent documents available.

Phase 2. Selection and edition (months 7 and 8) This will be conveyed to this project's applicants, who will consider the material for translation.

Phase 3. Translation and publication (months 9 to 12). A translator will implement the translation into English. A designer will format the Spanish and English documents into a publication.

#### Accessibility to the general public

An estimate volume of no less than 100 pages will be ready to be publish and a free digital e-book will be made available for better diffusion.

#### **CRITERION 4: Organizational Capacity**

#### **Applicant Organization and cooperating partner organizations**

The project will be implemented by the Anthropology faculty of the Humanities Division of the College of Liberal Arts and Social Sciences.

UOG will commit the salaries of Dr. Atienza and Dr. Jeffery, c. 8 weeks for organizing and implementing this project.

#### **Applicant organizational structure**

The Anthropology program is in the Humanities Division of the College of Liberal Arts and Social Sciences, which is headed by the Dean. The Dean's Office serves as the central coordinating and supervisory unit for the academic, research, and service activities of the College's four divisions. The Dean's Office is supported by an Administrative Officer and two secretaries. Functional and coordinating support for each division is provided by the Associate Dean, faculty chairs and secretaries.

#### Project staff biographies and position descriptions.

Staff biographies and position descriptions have been included for Dr. David Atienza and Dr. William Jeffery.

Dr. William (Bill) Jeffery has been working as a maritime archaeologist for over 30 years. Bill's background in maritime archaeology is in Australia, where after studying with the Western Australian Museum, he formulated and coordinated a maritime heritage program for a state government agency, Heritage South Australia from 1981-2001. He went onto working with the Federated States of Micronesia National Historic Preservation Office and completing a PhD in maritime archaeology at James

Cook University in 2008. He has implemented various types of archaeological and heritage investigations in Australia, the Pacific region, Hong Kong, Sri Lanka and various countries in Africa, including an Earthwatch funded project in Chuuk Lagoon from 2006-2008. Bill has lectured in cultural heritage preservation, maritime archaeology and conducted maritime archaeology field schools with Flinders University, Chinese University of Hong Kong, University of Guam and James Cook University in addition to teaching Nautical Archaeology Society (NAS) training programs in eleven different countries.

Dr. David Atienza received a PhD in Anthropology from the Complutense University of Madrid in 2006. He has taught history, philosophy, anthropology and applied linguistics at different institutions and universities in Spain. Dr. Atienza's research interests are focused on Cultural Identity Processes, Speech Analysis, Linguistic Anthropology, and Ethnohistory. He has published the book, *Viaje e Identidad: La Genesis de la Elite Quichwa-Otavalena en Madrid*, a multilocal ethnography product of fieldwork conducted in Otavalo, Ecuador and Spain or La Violencia del Amor, an edited volume focused on different perspectives on human violence. Dr. Atienza has recently published the articles "Death Rituals and Identity in Contemporary Guam" and "Embodied silent narratives of masculinities: Some perspectives from Guam Chamorros" and he is working in ethnohistorical interpretation of the Mariana history with articles like "A Mariana Islands History Story" or "Priests, Mayors and Indigenous Offices: Indigenous Agency and Adaptive Resistance In the Mariana Islands (1681 -1758)", among others.

#### Program management capacity

Both Dr. Atienza and Dr. Jeffery have implemented and successfully managed grants from the Guam Preservation Trust.

#### Fiscal management capacity

UOG has extensive institutional capacity to receive, administer, and manage various revenue streams.

#### **CRITERION 5: Project Impact and Evaluation**

#### **Expected project impact**

On completion of the project (1) an important aspect of Guam's and the Mariana Island's Underwater Cultural Heritage (UCH)—the Spanish connection—will be visible, which will greatly assist in protecting this valuable UCH; (2) Guam's role in the international trade and its history will be made public and diffuse; and, (3) this project will increase a better understanding of the Spanish historic period of Guam.

#### **Evaluation and monitoring process**

Evaluation on whether the project has been successful in a number of ways will be conducted through a combination of the following:

- Dr. Atienza will arrange and supervise the researcher in the Spanish archives;
- The translation services will be arranged and monitored by Dr. Atienza, in addition to providing \_ text for the publication as required;
- Dr. Jeffery will contribute to the publication's text in regard to protection and management requirements, and he will proof read the English material, and liaise with the University of Guam Press;
- After its release, the publication will be distributed for review with appropriate journals and to the Pacific Daily News;
- Evaluation will also be sought from maritime archaeology peers, through the UNITWIN Network of Underwater Archaeology, which UOG is an Associate Member;
- Evaluation will obtained through greater recognition of the importance of tangible underwater cultural heritage in Guam's cultural landscape through:
  - An increase in the commitment from Gov Guam and NPS on the protection, preservation and interpretation of underwater cultural heritage though a more active and publicized maritime archaeology program;
  - Feedback from the Guam community in the form of providing new site information;
  - o Students, community individuals seeking further maritime archaeology training.

#### **Project Goals**

HISTORIC PRESERVATIONS will be a series of three short documentary films based on the architecture, engineering, design and technology used to restore and rehabilitate Guam's historic structures and landmarks. The series will increase public awareness, education and outreach of the ingenuity, challenges and proficiency of past and present craftsmen. In addition, the series will help facilitate the dialogue of a renewed interest in historical, cultural and civic pride within our communities. HISTORIC PRESERVATIONS aims to shed light on structures and landmarks that have played significant roles within Guam's historic timeline with an emphasis on the technological processes of the people who restore and rehabilitate them for generations to come.

#### **Project Objectives**

Produced by award-winning CHamoru filmmaker and educator, Kel Muña, The HISTORIC PRESERVATIONS series is projected to feature three short documentaries that will focus on three historically and culturally significant structures and landmarks on Guam and will include an architectural and science/engineering perspective of the relationship from their original craftsmanship to their renewed and rehabilitated state. The three short documentaries in the series are to feature three historically significant structures/landmarks such as homes from the Historic Architectural District in Inarajan Village or the Guam Congress/Legislature building in Hagatna or the Inarajan Baptist Church for example. The series will attempt submission for screening at indigenous film festivals, including a partnership screening at the 11th Guam International Film Festival in 2021 (seating capacity is approx. 130 pax in the Guam Museum indoor theatre and average of 2,000 pax in annual attendance) with a possible panel discussion featuring the architect, engineers and organizations involved in each restoration. In addition there will be a televised viewership on PBS Guam (estimated viewership of over 60k Guam

residents) as well as possible online viewership on the websites of the Guam Preservation Trust and Pacific Preservation. The outreach will also include a social media campaign to document the process of the series production. The production may include current and former film students from Kel Muña's University of Guam Independent Filmmaking course in addition to the Guam International Film Festival Student Film Club and former or current students from the Guam Community College Visual Communications program.

Each of the three short documentaries is projected to have a total run time of between 10 to 12 minutes in length to accommodate flexibility for exhibition options of a bundled television broadcast, individual online viewing and film festival programming. The funds from the Guam Preservation Trust grant will be utilized towards the research & development, pre-production, production, post-production and promotional & educational outreach for the series. This process entails archival research, assistance from and correspondence with the Guam Preservation Trust, the Micronesian Area Research Center, various professional historians, educators, engineers, architects and administrators. Research and development is projected to take place from April 2020 to May 2020. Pre-production is projected from May 2020 to June 2020. Production is projected from July 2020 - August 2020. Post-production is projected to take place from September 2020 - January 2021.

#### **Expected Outcomes**

The anticipated results of the project will be that of professional national and international broadcast production and exhibition standards as seen in established media outlets such as PBS national and the Guam International Film Festival. The creative results of the projects will be to educate, inform, engage and entertain audiences about the artistic and technological methods and processes used by modern engineers, architects and designers in the preservation of historical structures & landmarks and their original utilitarian functions relative to their place in Guam's history.

#### **Project Location**

The project location will vary based upon the chosen historic structure or landmark to be featured within each short documentary in the series. The production crew will travel to each respective location to gather the necessary recorded visual and audio content for each short documentary.

#### **Description of the Product**

HISTORIC PRESERVATIONS will be a series of three short documentary films (10 to 12 minutes each) based on the architecture, engineering, technology and processes used to restore and rehabilitate Guam's historic structures and landmarks. The series will increase public awareness, education and outreach of the ingenuity and proficiency of past and present craftsmen. In addition, the series will help facilitate the dialogue of a renewed interest in historical, cultural and civic pride within our communities. HISTORIC PRESERVATIONS aims to shed light on structures and landmarks that have played significant roles within Guam's historic timeline with an emphasis on the technological ability of those who restore and rehabilitate them for generations to come. The project deliverable will be in the form of digital files or published streaming video that may also serve as promotional outreach material for the Guam Preservation Trust and Pacific Preservation organizations as well as educational reference material used for higher learning institutions with engineering and architectural programs.

#### Significance and Anticipated Benefits

One of the more significant aspects of the HISTORIC PRESERVATIONS series is the focus on its STEM (Science, Technology, Engineering and Mathematics) approach. With the STEM approach of each restored structure & landmark being the focus, each episode will also touch upon the humanities and social science aspects of each structure & landmark. This will yield another significance of the HISTORIC PRESERVATIONS series. Considering the compounding cultural trends that merge with today's globalized society, the series will bring attention to the importance of a preserved history. Additionally, the HISTORIC PRESERVATION series will be geared to reach a new type of audience; an audience that is now accustomed to consuming short-form content through mobile devices and online streaming. So in turn, its benefits are that it will deliver content of a historic past in a modern manner, which runs parallel to the historic structures & landmarks utilizing modern technology for restoration. This will hopefully expose these restoration efforts to a broader and more media-savvy audience. An increased benefit to this is that the featured structures & landmarks in each short documentary may create an appeal for tourists and locals alike to visit these locations as social media destinations, thus furthering the promotion of each featured structure & landmark.

#### Guam Preservation Trust Program - Public Interpretation and Presentation

This grant application is submitted under the Public Interpretation and Presentation program of the Guam Preservation Trust. The public appreciation and enjoyment of the project will be featured in multiple categories. The first will be in the category of Cultural Events with a public screening and possible discussion panel at the 2021 Guam International Film Festival. It will also fill the category of Publication of Information via a televised broadcast from PBS Guam and through the HISTORIC PRESERVATIONS online/social media outlets while providing streaming content for websites of organizations such as the Guam Preservation Trust and Pacific Preservation. In the final category, the series of short films may be utilized as education tools to assist educators in presenting lessons directly related to historic structures & landmarks.

## **Guam Preservation Trust Five Year Strategic Plan**

The HISTORIC PRESERVATIONS series exemplifies the basis of the methodology behind the Appreciative Inquiry as stated in the Guam Preservation Trust Five Year Strategic Plan - Discover, Dream, Design, Deliver.

The core advancement that the HISTORIC PRESERVATIONS series provides to the Five Year Strategic Plan is through Education and Outreach, bringing forth an in-depth look and analysis of the processes that involve the designation, designing, planning, engineering and technology used in the preservation, restoration and rehabilitation of historic structures & landmarks. The current masses are unaware of the precise details of planning and reasoning that are utilized in every restored structure & landmark. This series will help bring a higher degree of consciousness and appreciation to both the original and restored craftsmanship and the approach behind every featured preservation, restoration and rehabilitation.

Although Education and Outreach is at the center of the series, it also lends itself to the Capacity Building portion of the Five Year Strategic Plan. The HISTORIC PRESERVATIONS series develops an introduction to historic preservation for village communities to review and evaluate places that matter to them. It also helps to develop and train youth in oral history at the village level/family level by encouraging the sharing of stories, cultural values and civic pride.

#### Need

The specific need of the creation of short form documentary programs such as the HISTORIC PRESERVATIONS series is essential in order to continue the efforts of education, outreach and engagement of the preservation of historic structures & landmarks. This is evident in the constantly rising global consumption of video content. Statistics mark the overwhelming rise of video content as the most favorably engaging and trusted source of content for education and awareness. Reports from SmartInsights.com state "72% of people prefer video over text when learning about a product or service". A 2019 report from Zenith Media state "The global forecast estimates that the average person will watch 84 minutes of online video this year. This is up from an estimated average of 67 minutes spent per day in 2018. This rate of growth is not unusual, as Zenith reports that between 2013 and 2018 online video viewing grew at an average rate of 32% per year." They add to the forecast that the average person will spend 100 minutes each day watching online video in 2021. SocialMediaWeek.org reports "There has been a noticeable uptick in video usage over the past three years. A few stats evidencing this include that video consumption on mobile devices rises a whopping 100 percent each year. In addition, 78 percent of people report watching videos online each week while 55 percent of those watch on a daily basis. More than half (54%) demand more video content on top of what they already consume. Viewers claim they retain 95 percent of a message when obtained via video and a significant 92 percent of mobile users report sharing videos with others." Daniel Sarath, a Senior Digital PR Executive at Click Consult states "Memorable, emotive, video content gives brands the opportunity to connect on a more emotional level via stories that have a human interest." In 2017, around 80% of videos were under five minutes in length, however, these short videos tended to drive less than a third of overall engagement in video content. In comparison, videos that were 15 minutes or longer resulted in 50% of audience engagement according to SmartInsights.com.

#### Long-Range Goals

The efforts of preserving historic structures & landmarks extend much further than the brick and mortar. The efforts of the past and present engineers, designers, architects and builders are efforts that preserve tangible sites that are forever connected to our culture, history and civic pride. A long range goal for the HISTORIC PRESERVATIONS series is to continue the public dialogue and awareness of the efforts and significance of our historic structures & landmarks. In addition, the series will serve as an educational, informative and entertaining resource of

reference to the processes of site and structure restoration. By bringing these stories to the masses via short-form documentaries, it has the potential to spark the interest of future engineers, architects, planners and historians by encouraging the now technologically-savvy public to invest several minutes in a video and in return, receive educational and entertaining insight. As the rise in globalization, affordable travel and e-commerce contribute to a dilution of cultural awareness and identity, the time to preserve the historic narrative of our community is now. The short documentary films in this series can also serve as the template to a future catalogue of content over the coming years as additional short documentaries can be added to the series over time.

## **CRITERION 3: Project Approach**

The germ of the idea for creating the HISTORIC PRESERVATIONS series was conceived by Kel Muña during the summer of 2019. He was spending his summer as a Digital Filmmaking camp instructor for at-risk youth in the Sanctuary, Inc of Guam summer program. While on a field trip to Inarajan village, they experienced a tour of the Ana Leon Guerrero house, built in 1901. This sparked a strong curiosity for Kel as he didn't know of any existing structure on Guam that had been built prior to World War II, yet there it was. The first thought that came to his mind was of all the island's historic moments through which the house had survived. Second, it was the structure itself. He asked questions about its original foundation and design. The interior of the house triggered even more exciting questions. He asked, "Why were the door frames built so low? Is this the original wood floor? What kind of wood did they use to build the floor? How did they get the wood in here? Where is the wood from? Why is the roof A-framed? Who built this? Why was this house restored? Who restored it?" The thoughts and questions were endless and by the end of the tour, Kel knew that there was much more to be told about the science and engineering of the structure and that it was worthy enough to help bring the stories and awareness of these restored structures to the masses. Since then, Kel has been awarded a Distinguished Fellowship grant by the Guam Council on the Arts & Humanities to produce a short documentary production on the Ana Leon Guerrero house. Through his research, he has discovered that there are more structures whose restorations have been led by the Guam Preservation Trust. Feeling that such fascinating stories behind the science,

technology, engineering and history of these structures can go overlooked, Kel knew the most effective way to help tell them to the masses would be to create a series of engaging short form documentaries.

#### Partnership Planning

The project strategy for community involvement points to several arenas in Guam. First is the STEM aspect of the project. Second is historical and cultural. Third is the actual film production and distribution/exhibition. For the STEM insight into the structural and engineering research, Kel will connect with Guam Preservation Trust and their vast resources to STEM restoration information in regards to completed and current restoration projects and its experts. He will also target educators, historians and engineers at the University of Guam and the Guam Community College. He will also contact educational programs and student organizations such as the Society of American Military Engineers (SAME) and the Engineering, Mathematics, and Computer Science Club (EMC2). For historical and cultural information, he will connect with cultural consultants, historians and educators with the help of the Guam Preservation Trust, University of Guam and the Micronesian Area Research Center. For film production, Kel will connect with his network of local media industry professionals, target his former and current students from the University of Guam's Independent Filmmaking (CO401) and Mass Media Experience (CO394) courses as well as from the Guam Community College Visual Communications programs and from the 501(c)(3) non-profit Guam International Film Festival's Student Film Club, who are made up of various public/private Guam high school students. For distribution and exhibition, he will work with PBS Guam and the Guam International Film Festival. He will also publicize an open call for volunteers using his network of social media outlets.

## Implementation Plan

The HISTORIC PRESERVATIONS project will be carried out in six phases:

Research and Development (information and resource gathering)

Pre-Production (planning and scheduling of film production and gathering of archival material)

Production (filming/recording of content)

Public Outreach and Education (social media engagement)

Post-Production (editing of recorded content)

Exhibition and Distribution (theatrical screening, television and online streaming)

## Phase 1: Research and Development (April 2020 - May 2020)

During its first phase, the producer will manage the necessary research to decide upon the points of interest for each of the three short documentary films. This includes connecting and meeting with structural STEM experts, cultural and historical experts at various educational institutions, review archival material and relevance, and the securing of the production team and project staff. It's also in the first phase where the producer will conduct online research of similar film/video productions that are relevant to the topic. Finally, this includes the administrative workflow that will sustain the project.

## Phase 2: Pre-Production (May 2020 - June 2020)

The producer and director will formulate both the logistical and creative processes and workflow for the recording and visual direction of the three short films within the series as well as the cohesive narrative of the series itself. Previsualizations, scheduling production crew, securing and managing equipment/production gear, creating stations will be made - including digital still storyboards and mood boards from similar productions. Pre-Production will also include:

lighting/sound location scouts, property permissions, script-writing, scheduling of production dates, scheduling interview subjects and dates, ripboards, securing craft services provider, securing transportation, formulating overall arc of story order and presentation, securing/digitizing archival material and production release forms.

#### Phase 3: Production (July 2020 - August 2020)

The production team will record all necessary footage and audio on location. This includes footage of each structure/landmark, interviews with experts & consultants and the gathering/digitizing of archival material to be used within the documentary. This will also include the recording of scripts if necessary.

#### Phase 4: Public Outreach and Education (July 2020 - project completion)

The social media manager will oversee the project's social media engagement throughout the Production phase until the project's overall completion. During this time, we will include historical, cultural, architectural facts and educational information about each structure/landmark featured in the HISTORIC PRESERVATIONS series. This will also include photographs of the structure/landmark, its environment, its archival photos, before/after photos, featured profiles of critical persons involved in the restoration project of said structure/landmark and

behind-the-scenes photos/videos of the production of HISTORIC PRESERVATIONS. This will help to create, then enhance and broaden the awareness of not *just* the series, but the structures/landmarks themselves and the efforts it takes to preserve them.

#### Phase 5: Post-Production (September 2020 - January 2021)

The editor will have the challenging task to discreetly choose the amount of amassed recorded content and craft it into three cohesive final edits for the series. It's this phase that will take the most time to complete as it will include content review of all recorded material gathered during the production phase, implementation of music, sound editing, sound mixing, supervision of music, color grading/color correction and exporting of different files and formats for different deliverables. It will be the editor's job to be sure that the intended narrative arc of each short film and its featured structure/landmark has been achieved and that the editor accomplished the creative and technical goals set forth during pre-production and planning phase.

## Phase 6: Exhibition and Distribution (January 2021)

The public exhibition and distribution of the HISTORIC PRESERVATIONS series will be ready to deliver online within the month of completion, January 2021. The televised broadcast of the series by PBS Guam is proposed to take place during Summer 2021 to prolong the awareness of the project to new audiences and demographics that are true to the preference of legacy/traditional media such as PBS programming and content. Finally, there will be a theatrical screening (free to the public) in the Fall season of 2021 at the 11th annual Guam International Film Festival. The proposed free public screening may perhaps include a panel discussion featuring crucial people involved in the restoration of the structures/landmarks featured in the HISTORIC PRESERVATIONS series. After the festival, the HISTORIC PRESERVATIONS series can be made available to community and educational institutions for reference of engineering and cultural historic significance.

## Accessibility to the General Public

As stated in detail above in Implementation Plan phases 4 and 6, the accessibility of the project to the general public will include a public call for volunteers to participate in the Public Outreach and Education social media detail. Accessible viewing for the general public will be made available through a televised broadcast on PBS Guam, proposed free theatrical screening and discussion panel at the 2021 Guam International Film Festival and online streaming via various

organization's websites. Lastly, availability for the accessible public can be made possible by community institutions for reference of engineering and cultural historic significance.

## **CRITERION 4: Organizational Capacity**

## **Applicant Organization and Cooperating Partner Organizations**

Kel Muña may serve in several capacities within the project, but his main role is that of Project Director/Producer.

Known as a pioneer of independent film in Guam and the Western Pacific, Kel Muña has over twenty years of experience in radio, television and film production. He is the founder and Program Director of the Guam International Film Festival, a 501(c)(3) non-profit organization now in its tenth year and is co-founder of the student-run University of Guam Film Festival now in its sixth year. He has been featured in international publications such as USA Today, Filmmaker Magazine, CNBC.com and others.

As an educator, he has developed the first independent filmmaking course curriculum for the University of Guam as well as for various scholastic and non-profit community youth programs such as the College Access Challenge Grant Program and Sanctuary Inc, Guam. As a filmmaker, he is recognized as the producer and director of Guam's first indigenous feature length film unprecedentedly utilizing the CHamoru language in film. His award-winning works have been featured in academic publications and have screened in numerous countries and film festivals around the world. In addition, his films have been part of sociological, cultural, international and Pacific course studies at Purdue University, Kyoto Museum, University of Hawaii, University of Guam, Guam Community College and various Guam Department of Education High Schools.

Most recently, Kel has been awarded as a 2019 Distinguished Fellow by the Guam Council on the Arts & Humanities Agency. In addition, he has been invited to serve as a guest panelist in the 2019 Hawai'i Media Makers Summit alongside representatives from Sundance, Tribeca and Tahiti Film Festivals. He currently teaches Independent Filmmaking and Mass Media

Experience at the University of Guam and is the new host of the Airing the Arts program on KPRG-FM, Guam's National Public Radio affiliate. Kel is an active advisor to the Guam Film Office and continues to mentor at-risk youth through various scholastic and non-profit organizations. He holds a Master of Arts Degree in Communication and is committed to utilizing the motion picture as a medium for socially conscious artistic expression and the awareness of cultural identity.

The planning of the HISTORIC PRESERVATIONS series will approach the following organizations for project support through various levels of production. Kel continues to have a long and successful working relationship with each. Organizations such as the Guam International Film Festival and PBS Guam have provided verbal commitments in their secured partnership for exhibition and distribution.

For in-kind donations, the project will be receiving an additional \$19,356 of value in the form of home-office space rental and office internet services from Naomi Castro-Muna along with camera, audio and post-production editing equipment package rentals from the Guam International Film Festival, transportation rental and fuel costs from Kel Muña and two volunteers for various general tasks. The volunteers have not been confirmed yet because it is, at this time, too soon to commit to an event projected for April 2020. We will be making an open call for volunteers closer to the date.

## Identify and Justify the Hiring of Employees of the Proposed Project

The employees identified for the hiring of the HISTORIC PRESERVATIONS series project will be targeted in terms of their proficient capacity in film production and their involvement in community, education and cultural efforts. These traits will be targeted in the hiring of local media industry professionals & organizations, educational institutions and relevant groups/clubs. This includes former and current film and media students from University of Guam, Guam Community College and Guam International Film Festival's Student Film Club. It would be a preference to identify those who are not only technically sound, but have an affinity for positive action within the communities in which they live. These tend to be people who are personally invested in volunteership, who have worked with like-minded organizations in the public, private and non-profit sectors, and those with a consciousness of connecting their knowledge of heritage to their future as aligned with the methodology of the Appreciative Inquiry as stated in the Guam Preservation Trust Five Year Strategic Plan - Discover, Dream, Design, Deliver. From past projects, Kel has experienced that by aligning like-minded individuals with a common belief you create a strong and efficient movement to any team effort.

## **Impact Statement**

The expected project impact of the HISTORIC PRESERVATIONS series is estimated to benefit up to 72,000 individuals. These figures are projected from the media outlets and engagement of the vested organizations involved within the project. This includes the viewership from the televised broadcast on PBS Guam (estimated viewership of over 60k Guam residents), the theatrical screening at the 2021 Guam International Film Festival (average of 2,000 pax in overall festival attendance), and social media accounts (Kel Muña's personal social media following of 6.3k followers, Guam International Film Festival's social media following of 8.3k

followers, Guam Preservation Trust's social media following of 888 followers, PBS Guam's social media following of 2.9k followers). The figures of impressions/engagement may grow with the educational and promotional outreach of potential subsequent viewership from future online streaming, school presentations, conference/industry screenings, etc.

I am writing to support the application of Kel Muna as an instructor at the University of Guam. I have known Mr. Muna for many years and worked with him on several projects. He is someone who is dedicated to the Guam community and has shown this through his many activities, some of which I will describe in this letter.

He is also someone who has shown a true commitment to inspiring the youth of Guam and helping give them the professional skills to compete in media markets locally and nationally. I first met Mr. Muna in 2008 just as he and his brother Don were premiering their film Shiro's Head, the first "made in Guam" film. Numerous earlier films had been made on Guam, but this was the first film that didn't just use Guam as a generic island backdrop, but was made to represent Guam, Chamorro language and culture.

The Muna Bros as Don and Kel are known as, went on to show their film elsewhere in the Pacific and the United States. They helped garner international attention for Guam through their traveling with the film, and this helped lead to the next stage in their careers. After the Muna Bros had difficulty finding support or finding for their next film, they decided that what was needed for Guam was not just more films, but a better infrastructure and support system for aspiring actors, screenwriters, directors and others who make filmmaking possible. In 2011 they brought a number of different community stakeholders together to create Guam's International Film Festival.

The festival showcased films from around the world, not just the Asia-Pacific region and more importantly became a venue for local artists and professionals to premiere their own efforts. The festival has continued annually since then, and the Muna Bros have been very particular about using it as a venue not just for films, but also for professionalization. Dozens of UOG and GCC students are used as volunteers, interns and staff and learn the ins and outs of running a festival and an internationally established event.

In addition to this the Muna Bros have held countless workshops at the high school, college and the general community levels helping people gain important knowledge and skills related to making their

own films. They are frequent guest speakers in communication classes at UOG. This engagement with the community is distinguishes Don and Kel from being simple filmmakers, but instead artists and intellectuals who understand their obligation to Guam and Micronesia, to take what they have learned, sometimes the hard way, and ensure that those that follow might have a slightly or significantly easier journey.

This community commitment culminated last year in the release of their second film, a documentary titled Talent Town. I was fortunate enough to be interviewed as part of their documentary and included in their final cut. The film is a conversation piece on the state of art and culture in Guam today, both the advantages that people in Guam have, but also the limitations and things they might struggle against. After screening the film here they took it on a tour across the United States, showing it in states with a significant Chamorro population, such as Washington, Nevada, Texas and California.

In conclusion, I highly recommend Mr. Muna as an instructor at the University of Guam. He will bring with him so much knowledge and passion that can not only educate our students, but also hopefully inspire them. I look forward to encouraging Chamorro Studies majors and minors to take his courses in order to help blend their own desire to perpetuate and promote aspects of Chamorro heritage with contemporary media, most importantly film. ### Histories of Agriculture and Farming on Guåhan

### Introduction and Project Overview

Guåhan Sustainable Culture (GSC) is organizing an archival research and oral history project on the Histories of Agriculture and Farming on Guåhan with a culminating interactive exhibit that will be launched in July 2020 at the Sagan Kotturan Cultural Center in Tumon. In order to envision a future of environmental sustainability and food sovereignty on Guam, GSC hopes that a look into history will provide the island with knowledge of sustainable practices lost to time, reconnect people with their ancestors, and, most importantly, encourage profound connections to the land and island. In other words, knowledge of innovation in farming and agriculture on Guåhan requires a revitalization of cultural practices rooted in Guåhan's culture. A Guam Preservation Trust grant will supplement a Humanities Guåhan grant that will allow GSC to research and share local knowledge related to the histories of agriculture and farming on Guåhan through archival research, oral histories with various families, community engagement through a community workshop, and an interactive exhibit.

In preparation for this exhibit, GSC's research team will collect the histories of agriculture and farming on Guåhan through oral histories and archival research, and subsequently - with the permission of participants- share these stories, strategies, and practices with the island community through online social media platforms, workshops and exhibit. In doing so, GSC hopes to connect past and present in order to reinvigorate the island communities' relationships to history and the land through sustainable farming and agriculture.

### Need for Assistance

Guam Preservation Trust mission is to "preserve and protect Guam's historic sites, culture, and perspectives for the benefit of our people and our future". One of its mandated purpose is to award grants for the collection of Guam's oral history. GSC's Histories of Agriculture and Farming on Guahan project

will further GPT's current Five Year Strategic Plan in that will contribute to the preservation of the oral histories of farming and agricultural practices rooted in Guam's culture.

GSC's mission is to cultivate ideas and strategies of environmental sustainability within the local community through practical education, social engagement, and collaborative partnerships. GSC believes that environmental sustainability translates into the well-being of the island community. GSC envisions a Guahan where its people strive toward food sovereignty and greater food security, where its people are proficient in cultivating their own food, and most importantly, where its land, air and seas are sustained for future generations.

GSC's mission is to tackle each of these concerns in a holistic manner with specificity to Guam's community. Education regarding past practices of farming and agriculture can and will inform present and future initiatives and technological innovations to improve and expand environmental sustainability and food sovereignty. It is a way to revitalize successful farming and agricultural practices in order to create food systems that are sustainable, more nutritious, readily available, and affordable for Guam's community. GSC intends to generate a body of local knowledge that is more efficient for Guam's environment and culture.

### Project Approach

Histories of Farming and Agriculture on Guåhan was conceived by the GSC's board members soon after the organization was formed in January 2019. After several community workshop, events and meetings with various members of the community, it became apparent that the community desired to know more about the histories of agriculture and farming on Guam. Members of the community at these events debated whether people of Guam were fully sustainable in the past with respect to cultivating their own food. Questions arose about farming practices of past generations and whether they can be shared with current and future generations in the desire to move towards a more sustainable community.

GSC hopes that the archival research and collection of oral histories will shed light to these questions and actively engage members of the community into meaningful conversations about the past and how

learning about past agriculture and farming practices can contribute to the quest for greater food security and food sovereignty.

### Organizational Capacity

Guåhan Sustainable Culture (GSC) is a 501(c)(3) non-profit organization incorporated as Oceania Ascent Education, Inc. Founded in January of 2019, GSC seeks to educate the community about sustainable practices, partner with other organizations to encourage wider participation in the local environmental movement, and nourish the island through providing healthy, locally-grown foods. GSC believes that environmental sustainability translates into the well-being of our island community. In addition to Co-Founders Michelle Crisostomo and Marlyn Oberiano, GSC's Board of Directors includes Kristin Oberiano, Denise Crisostomo, Terrence Brooks, Ruben Payumo and Jose Garcia. David Crisostomo is GSC's environmental consultant.

Kristin Oberiano and Elyssa Santos will supervise a research team of college-level students in the research of archival documents, the collection of oral histories, and the synthesis of primary and secondary sources. Kristin Oberiano is a PhD candidate in History at Harvard University. She earned her Master's degree in History from Harvard University in 2018, and her Bachelor's of Arts in History and American Studies from Occidental College in 2016. Elyssa Santos graduated with a Master's degree in Pacific Island Studies from the University of Hawai'i at Manoa and her Bachelor's degree in Chamorro studies from the University of Guam. Her Master's thesis, "Practicing Economy': Chamorro Agency and U.S. Colonial Agricultural Projects, 1898-1941" explored the history of agriculture and farming on Guam in the Naval Era.

Michelle Crisostomo will act as project director and she will facilitate planning meetings, coordinate individuals and logistics throughout the project duration, plan the culminating exhibit and assist with website content. Crisostomo holds a B.S. in Business Management at Webster University. Crisostomo has significant work experience in business management, development, fundraising, and marketing.

Marlyn Oberiano will act as fiscal director and she will be in charge of the projects budget and financial reporting. She will assist as needed during the duration of the project and on the day of the

culminating event. Oberiano worked at Ernst and Young for 25 years as a Certified Public Accountant.

Oberiano has ample experience assisting organizations with their non-profit status with the government as well as with their financial reporting.

Denise Crisostomo will act as media/marketing director. She will coordinate and plan the video production with a 3<sup>rd</sup> party company including contacting participants for the oral histories, coordinate website creation, create social and digital media content, and advertising.

GSC was formed in January 2019 and has since been building capacity to able to compensate staff to carry out its mission. Work with the organization has been primarily voluntary by its officers and directors. In September 2019, GSC received an \$9,595 grant from Humanties Guahan for this project. Due to the limited funding available from Humanities Guahan as well as its matching grant requirements, anticipated expenses related to this project are not fully funded. In addition to this GPT grant request, GSC plans to solicit additional monetary and in-kind support from the community to fund this project.

### Project Impact and Evaluation

For the community workshop and exhibit, a survey will be shared, electronically and in hard copy, to evaluate the effectiveness of the oral history project and exhibit in informing the participants about the history of agriculture of Guam, its potential in influencing their farming or agricultural practices, as well as facilitating greater understanding, self-reflection, opportunity for the expression of different ideas.

At the end of the exhibit tour, participants will be asked to share digitally their thoughts about the presentation subject matter and share on social media. We would ask them to complete the sentence, "Farming on Guåhan is important because...," in order for the participants to critically engage in the multifaceted research and stories presented. In addition, GSC will have a chalkboard wall for participants to immediately respond to the exhibit with a few words, phrases, doodles, or drawings. We hope that a community conversation will evolve as a result of various voices participating and sharing on this wall. Furthermore, the chalkboard wall will be a way to immediately receive feedback from participants and an innovative way to share thoughts with other participants at the exhibit itself.

### Conclusion

Guåhan Sustainable Culture hopes that collection of oral histories of cultural practices in agriculture and farming on Guam will provide the island with knowledge of sustainable practices lost to time, reconnect people with their ancestors, and encourage profound connections to the land and island - which in turn will lead to greater food sovereignty.

Histories of Agriculture and Farming in Guåhan Guam Preservation Trust Grant Application Budget Narrative

Guåhan Sustainable Culture (GSC) was formed in January 2019 and has since been building capacity to able to pay for staff. Work with the organization has been primarily voluntary by its officers and directors. Due to the limited funding available from Humanities Guahan as well as its matching grant requirements, anticipated expenses related to this project are not fully funded. As such, supplemental funding is requested from Guam Preservation Trust in the following:

### Personnel (directly related to project)

Project Director: 50 hours at \$25 per hour- \$1,250. Facilitate planning meetings, coordinate individuals and logistics throughout the project duration, plan the culminating exhibit and assist with website content. Humanities Guahan has agreed to fund \$935. Request supplemental funding from GPT is \$315.

Fiscal Director: 25 hours at \$25 per hour-\$625. Preparation of project budget, disbursements of expenditures, prepare financial reports and assist on the day of the culminating exhibit. Humanities Guahan has agreed to fund \$300. Request for supplemental funding from GPT is \$300.

Media/Marketing Coordinator: 35 hours at \$25 per hour -\$875. Coordinate and plan the video production with a 3<sup>rd</sup> party company including contacting participants for the oral histories. Coordinates website creation, create social and digital media content, and advertising. Assist on the day of the culminating exhibit. Humanities Guahan has agreed to fund \$650. Request for supplemental funding from GPT is \$225.

### Honoraria / Research Assistants

Humanities Scholars: GSC had initially requested from Humanities Guahan a stipend of \$500 each for the 2 scholars for about 40 hours of planning, research and oversight. However, based on preliminary planning and an initial review of research materials, it is anticipated that at least an additional 20 hours each will be necessary. Request for supplemental funding from GPT is \$500.

The project involves archival research by 3 university students and will be led by the two humanities scholars. The humanities scholars will coordinate research, assist in the writing and editing of the final research paper, collaborate with project director and media coordinator for content for the website and exhibit. Assist on the day of the culminating exhibit.

Research Assistants: Likewise, additional hours are anticipated for the assistants. Humanities Guahan has agreed to fund \$1,200 for 3 research assistants. Request for supplementary funding from GPT is \$1,050.

Farmer Interviewees: \$1,700 – A significant aspect of the project is the oral stories of eight to 10 farmers. They each will be awarded an honorarium for their contribution based on their level of participation. GSC is not requesting supplemental funding for interviewees.
