MINUTES

1.0 CALL TO ORDER/ROLL CALL

The meeting was called to order by Vice Chairman Vincent Leon Guerrero at 3:12 p.m., and roll call was conducted.

2.0 ELECTION OF OFFICERS

2.1. Board Secretary – Ratification

With no objection, Vice Chair Vincent Leon Guerrero recognized and transferred the Chair to Chairman Michael Makio to preside over the meeting.

Joe Quinata reported Dave Lotz agreed and accepted the nomination as Board Secretary.

Nicole Calvo motioned to ratify the motion of the slate of GPT Board Officers made during the previous Board meeting, confirming the nominations with Dave Lotz as Board Secretary. The motion was seconded by David Atienza.

There being no further discussion the motion was unanimously approved.

3.0 APPROVAL OF MINUTES (January 13, 2021 Meeting)

Chairman Makio opened the floor for discussion on the minutes of January 13, 2021. Nicole Calvo motioned to approve the minutes of January 13, 2021 as read.

The motion was seconded by Edwin Reyes.

With no further discussion the minutes were unanimously approved.

4.0 OLD BUSINESS

4.1. Planning Committee

Committee Chair Dave Lotz reported the committee met to discuss the Hila'an Proposed Conservation Easement Project to save cultural resources on Hila'an property. The committee discussed the Multi-Year Encroachment Protection Agreement with the Dept. of the Navy. The Agreement will allow GPT to purchase the conservation easement with REPI funds. MotionDave Lotz motioned to allow the Chief Program Officer to enter into an agreement with
the Department of the Navy to initiate the process to acquire the funding for the Hila'an
Easement Project. The motion was seconded by Nicole Calvo.

Chairman Makio opened the floor for discussion.

Joe Quinata reported a hike along the waterfront to Hila'an is scheduled for Saturday, February 13th. Interested Board members are to meet at Tanguisson Beach at 8:00 a.m. The property is privately owned by Polaris Guam LLC and contains several archaeological sites.

Subsequent Board motions will follow upon completion of proper archaeological and land surveys, environment assessments, and land appraisal.

The island will benefit in the effort of cultural, geographic, and agricultural preservation.

The Board continued to discuss the following: 1) REPI funded programs on island managing the fence lines between military and civilian properties; 2) public access to the property; 3) no conflicting overlay of the firing range; and 4) if acquired, GPT will own and manage the property to protect the artifacts and natural resources of the land.

A press release will be issued once the transactions is finalized.

With no further discussion, the motion was unanimously approved.

4.2. GPT Board Orientation

Joe Quinata reported an email was circulated to the Board requesting convenient dates and times to schedule the Board Orientation. Feedback is still pending from all Board members. Board members will be advised once a date is confirmed.

5.0 NEW BUSINESS

5.1. Archaeology Research Grant Application – Eddie C. Pelkey

Joe Quinata reported property owner Eddie Pelkey is in the process of building his home. In the effort to obtain clearances, the SHPO office has required the homeowner to have an archaeological survey conducted on the property. The survey would incur additional costs to the homeowner which is not an allowable cost for bank home loans. In the past, GPT has assisted homeowners fund archaeological surveys. Staff recommended to refer the application to the Grants Committee for review and recommendation to the full Board.

Dave Lotz inquired on the cost of the survey and suggested to hold a meeting with the SHPO to discuss the scope of work required on the property.

Chairman Makio referred the application to the Grants Committee and recommendation at the next Board meeting.

6.0 COMMITTEE REPORTS

6.1. Budget & Finance Committee

6.1.a. YTD Balance

Joe Quinata reported the current fund balance is \$1,803,435.38. The total obligated fund for approved grants and projects is \$1,154,979.83 with a remaining balance of \$648,455.55 restricted for grants and projects in queue.

An additional \$98,000.00 was received by GPT from the collection of permit fees for the first Quarter of FY2021.

6.1.b. Citizen Centric Report

Joe Quinata reported the Citizen Centric Report has been completed as mandated by the Office of Public Accountability (OPA).

The report provides the community with a brief overview of the finances and programs for fiscal year 2020.

The report is sent to the OPA, the Speaker of the Guam Legislature, and posted on the GPT website.

6.2. Architecture Committee

Refer to Report

Joe Quinata reported the Architectural & Engineering (A&E) plans for the George Flores House is ongoing.

The A&E for the Rosario & San Nicolas Houses are completed and will enter the phase of construction upon availability of funds.

6.3. Grants Committee

Refer to Report

Joe Quinata reported due to the pandemic new grant applications are very minimal in comparison to previous years.

A few on-going grants are experiencing delays due to the pandemic restrictions. Board will be kept informed of grants near completion.

Ekungok I Estoria-ta

Joe Quinata reported the project has received the additional funding.

Field trips have commenced for teachers to become familiar with the respective historic sites. The project involves narratives in Chamorro and the production of songs and cultural dances for each site.

Public Broadcasting Service (PBS) has partnered with GPT to produce a ten (10) minute video of each site as a tool to teach and as a virtual fieldtrip.

A panel will present the project at the upcoming Marianas History Conference and will also be presented at the National Trust for Historic Preservation conference in Washington, D.C.

6.4. Archaeology Committee

Refer to Report

Joe Quinata reported programs are on hold due to the pandemic restrictions. Although an instructor has been identified to conduct the archaeological technician training it will not be scheduled until the pandemic restrictions are lifted.

7.0 OPEN DISCUSSION/ANNOUNCEMENTS

500 Year Commemoration of the Circumnavigation of Ferdinand Magellan Joe Quinata reported due to the pandemic scheduled events have either been cancelled or virtual presentations will be conducted.

The annual Cultural Heritage event in Umatac has been cancelled.

GPT will be working with the Guam Museum on the exhibition for display upon the reopening of the museum.

To highlight the event leading up to the arrival of the Elcano ship, PDN will publish the stories prepared by the four (4) young scholars.

Under orders from the Spanish government, the crew will not be allowed to disembark from the ship during their visit to Guam.

David Atienza announced the ship is scheduled to be on Guam from March $1^{st} - 6^{th}$. The ship will be escorted by the military upon arrival and docked inside the wharf on base. The only extent of engaging public interaction is by a group of proas sailing to meet the ship as it approaches the island.

On March 2nd documents will be presented and donated to MARC by officials from Spain who will have arrived on Guam prior to the ship's arrival.

Marianas History Conference

Joe Quinata reported the conference currently has 65 presenters with over 300 scholars registered to attend the nine (9) day virtual conference.

There is no conference fee.

Board members were encouraged to register to attend.

8.0 ADJOURNMENT

There being no further discussion, Dave Lotz motioned to adjourn the meeting. The motion was seconded by Pale' Eric Forbes.

ITEM 4.1. PLANNING COMMITTEE HILA'AN PROPOSED CONSERVATION EASEMENT PROJECT





Introduction

In keeping with the mission of the Guam Preservation Trust to preserve and protect Guam's historic sites and perspective for the benefit of the people of Guam, the opportunity to save significant historic properties in Hila'an is proposed by the Hila'an landowner (Polaris Guam LLC) with partnership and assistance from the Department of Defense's (DOD) Readiness Environmental Protection Integration (REPI) program.

Significance

Archaeological sites in Hila'an are listed in the Guam Register of Historic Places and determined to be eligible for listing in the National Register of Historic Places. The site is located within the northwestern portion of the property and consists of an extensive latte settlement containing approximately 18 latte sets located on the coastal flats between the reef and the base of the high cliff line. Rock shelters and caves are also located within the Hila'an Historical Site. The site is registered in the Guam Historic Properties Inventory as the Hila'an Complex, Site No. 66-08-0005.





Proposed Conservation Easement

Approximately 100 acres is proposed for the conservation easement that includes the latte settlement, caves and area along the foot of the cliff line, and possibly Lost Pond (refer to map overlay below). The conservation easement will be delineated through land survey to be conducted. In addition, Environmental Phase I assessment will be conducted to ensure contamination-free sites prior to any land transaction. Property appraisal will be conducted for valuation. Guam Preservation Trust will contract services for land survey, environmental phase I, and appraisal with funding through a cooperative agreement between GPT and EPA/DON (approximately \$150,000.00). Note: Environmental Phase I is proposed to be borne by GPT.

Guam Preservation Trust will purchase the conservation easement with funding from the DON estimated to be no less than \$1,000,000 with actual funding availability based on the difference in value, if any, of Navy's restrictive use easement and GPT conservation easement. The conservation easement agreement will allow for compatible ecotourism activities and access/security/utility infrastructure that align with GPT's historic preservation mission and REPI's habitat conservation purposes. The agreement will also anticipate issuing a restrictive use easement to the NAVFAC Marianas to protect REPI interests and to comply with the Navy's program rules.



Readiness Environmental Protection Integration Program (REPI)

The Department of Defense (DoD)'s REPI Program is a key tool for combating encroachment that can limit or restrict military training, testing, and operations. The REPI Program protects these military missions by helping remove or avoid land-use conflicts near installations and addressing regulatory restrictions that inhibit military activities. The REPI Program is administered by the Office of the Secretary of Defense (OSD).

A key component of the REPI Program is the use of buffer partnerships among the Military Services, private conservation groups, and state and local governments, authorized by Congress at 10 U.S.C. § 2684a. These win-win partnerships share the cost of acquisition of easements or other interests in land from willing sellers to preserve compatible land uses and natural habitats near installations and ranges that helps sustain critical, at-risk military mission capabilities. For more information on REPI buffer partnerships, review the primer here.

REPI also supports large landscape partnerships that advance cross-boundary solutions and link military readiness, conservation, and communities with federal and state partners through a common, collaborative framework. Such partnerships include the Southeastern Regional Partnership for Planning and Sustainability (SERPPAS) and the Western Regional Partnership (WRP), and REPI also participates in the Sentinel Landscapes Partnership among DoD and the Departments of Agriculture and the Interior.

GRANT PROPOSAL GUIDELINES

- Application must fall within the categories specified by the Guam Preservation Trust (GPT) Programs and the FOCUS projects of the Fiscal Year. See "Circular 2020-A"
- Proposed activities should take place entirely or substantially within the Territory of Guam.
- Applicants should concentrate their grant proposals on topics related specifically to Guam.
- Grant Applications should be completed in full, regardless of the scope or the amount budgeted.
- Proposed projects must demonstrate a clear commitment to authenticity and preservation.
- I Grant projects must be balanced and non-partisan.
- GPT requires a cost-share by each grantee either in cash or in-kind contributions for the grant proposal.

WHO MAY APPLY

- Applicants may be individuals, community organizations or societies, community galleries or museums, religious or faith based organizations, humanities councils, registered nonprofit organizations, ethnic clubs, festival sponsors/organizers, or educational institutions.
- Individual Applicants must be U.S. citizens and residents of Guam. Individual applications who do not meet the above criteria may affiliate themselves recognized Guam-based organizations for Sponsorships.
- Government entities may apply. However, such grant applications are governed by Public Laws 20-151, 21-07 and 27-89, which prevent the use of GPT funds for operational expenses.

BUDGET GUIDELINES

- Budgets must be submitted on separate sheets of paper. The heading: "(Name of the Grant Project) Budget" must be at the top of the page.
- 2. Budget should include all applicable costs, such as project staff, supplies, equipment and miscellaneous.
- 3. Budgets should be divided into sections by category (such as staff, supplies, etc.) and then itemized and sub-totaled within each category and subcategory.
- 4. A glossary of technical terms should be provided as an attachment to the proposed budget (if applicable).
- 5. In-kind contributions should be included.

PROHIBITED COSTS

- 1. Purchase of equipment.
- 2. Rental of office/storage space, except for approved museum collections.
- 3. Salaries of full-time positions or positions considered by GPT to be full-time and not related to specifically to the project.
- 4. Mileage

ALLOWABLE COSTS

- 1. Fees for personnel involved in the grant project.
- 2. Cost for materials and supplies related to the development and implementation of the project.
- 3. Costs for the contractual services (such as renting equipment or professional assistance) to be provided as part of the grant project.
- 4. Acquisitions, collection, care and conservation costs.
- Modest costs associated with training community members to perform continuing work in documenting, preserving and enhancing historic places and perspectives.
- 6. Direct costs of mounting exhibitions, displays or presentations that promote the preservation of and education of historic places.

The costs described above do not comprise of a definitive list. Other costs may be allowed at the discretion of the GPT Board.

- 1. Requests for general operating support or assistance with annual funding needs, except as an allowable portion of requests to support specific projects.
- 2. Requests in conflict with the spirit of Public Laws 21-151, 21-07 and 27-89.

Although primarily tasked with restoring historic structures, which are listed in the Guam Register of Historic Places and/or the National Register of Historic Places, GPT also funds various types of cultural preservation projects.

COMMUNITY PARTNERSHIPS

In 2020, the Trust partnered with over 50 public and private organizations, and individuals from the community to oversee 20 grants and projects to accomplish our *proposed outcomes* (Goals) for the year. All have been successful in their respective delivery to the community for their benefit and appreciation.

For the last five years (2015 – 2020) The Guam Preservation Trust Board of Directors approved a total of \$3,474,130.00 for the rehabilitation and reconstruction of eight historic structures on Guam; the *Historic Guam Congress Building*, Hagåtña (A/E Design & Construction), the *F. Q. Sanchez School*, Humåtak (A/E Design), the *Antonia Chargualaf House* Inalåhan (A/E & Construction), the *Doris Flores Lujan House*, Inalåhan (A/E Design & Construction), the *Doris Flores House*, Inalåhan (A/E Design & Construction), the *Juan Flores House*, Inalåhan (A/E Design), the *Vicente Rosario House*, Hagåtña (A/E Design) and the *Historic Courthouse*, Hagåtña (A/E Design). Although all eight capital projects have completed their respective Architectural and Engineering Design process, five projects completed the construction phase and are now functional facilities. The Guam Preservation Trust continues to provide for education and outreach in various formats and due to the COVID 19 Pandemic, these activitles have either been postponed or have changed to virtual formats.

The **Guam History Day** (<u>www.guamhistoryday.weebly.com</u>) competition for middle and high school students was transformed virtually in place of the traditional face-to-face event.

Ekungok Estoriå-ta (<u>www.pacificpreservation.org/eie</u>) professional development workshop for CHamoru teachers was postponed and may be replaced by virtual training format.

The **Architecture and Architects of Guam Book** was launched outdoors with multiple launch events to accommodate registered participants and meeting the COVID 19 mandated orders from the Governor of Guam.

The *Humåtak Archaeology* (<u>www.pacificpreservation.org/humatak</u>) was postponed until summer of 2021.

EXPENDITURES

The Trust receives most of its revenues from the Building Permit Fees administered by the Guam Department of Public Works. For FY 2020, a total of \$505,005 was collected from building permit fees due to the Guam Preservation Trust, a decrease of \$315,224 or about 38% from the FY 2019 total of \$820,229. This decrease is attributed to the decrease in construction activity in 2020.

Interest income on investments increased between FY 2019 and FY 2020. In FY 2020, \$141,585 was earned on interest income, compared to \$66,808 in FY 2019. The increase is attributed mainly to the fact that there were no drawdowns for the year. Overall expenditure for FY2020 was \$744,455, a decrease of approximately 39% from FY 2019 total of 1,211,168. This is attributed to the adherence of strategies from the Guam Preservation Trust COVID 19 Response and Guidance/Financial Analysis to Address Economic Impact Due to COVID.



FINANCIAL OUTLOOK

WHERE TO FIND GPT IN 2021



- Ekungok I Estoriă-ta Second Series With grants awarded by the National Endowment for the Arts, and GEDA Qualifying Certificate, GPT will assist in the preservation of the CHamoru language innovatively as well as provide intergenerational exchanges between *i manhoben* (youth) and *i manâmko* (the elderly), with a second series to teach CHamoru using historic places. Curriculum will be created in CHamoru and comprehension will be assisted through the creation of video vignettes and a melodic component.
- Pacific Preservation Technology Project Through grant funding from the Office of Insular Affairs' (OIA) Technical Assistance Program, GPT will assist in the development of a shared educational digital technological resource and tools for preservation stakeholders from the six Pacific Insular areas of American Samoa, the Commonwealth of the Northern Mariana Island, Guam, the Federated States of Micronesia, the Republic of the Marshall Islands, and the Republic of Palau to increase the preservation technology network to sustain historic, cultural, and national resources in the region.
- Marianas History Conference- GPT will once again be a sponsor of this event that explores the research and experiences of the people of all the Mariana Islands. As it also marks the 500th year of Spanish explorer Ferdinand Magellan's contact with Guam, this conference will continue to provide contact of the stories of the Mariana Islands with the rest of the world.
- Completion of the Architect and Engineering plans for the Historic Vicente Rosario House in Hagåtña.
- Section 106 Training GPT will offer essential Section 106 training primarily geared toward the Guam community.
- GPT will engage with the heritage partners local and national on advocating for continued and holistic preservation of our heritage sites during renegotiations of preservation agreement documents.
- With the creation of a standing committee, the Planning Committee has been tasked to determine the feasibility of adding sites to the Guam and National Register of Historic Places.

As our Chief Program Officer has been appointed as a member of the Board of Trustees of the National Trust for Historic Preservation, GPT will use this opportunity to raise preservation advocacy of issues of concern in our Pacific Region.



- Guam Rock Art grant awarded Andrea will investigate the rock art of Guam using state of the art technologies and through community engagement This inventory will be used to make a conservation .to better understand our heritage.
- Preparation of National Historic Landmark Nomination for the Manenngon Concentration Camp-Through grant funding from the Organization of American Historians (OAH), GPT will work with researchers to produce a complete National Historic Landmark (NHL) nomination for the Manenngon Concentration Camp in the Municipality of Yona.
- Guam & National History Day Competition: GPT will assist in funding students to compete and represent Guam in the National History Day competition at the University of Maryland.
- Kantan Hereru A Blacksmith's Song/Film -The completion of the Kantan Hereru project; a blacksmith's song short film.
- GPT will increase outreach to the public through the use of its facilities through partnerships with Department of Public Health and Social Services-Worlds AIDS day, Nihi Inc., Guampedia.com, and the Department of Education Librarians.
- Spanish Shipwrecks on Guam : Highlighting the value , potential, and awareness of Guam's underwater cultural heritage.
- Architectural and Engineering Plans for the Augustin San Nicolas House in historic district of Inalahan and the Vicente Rosario House in the historic district of Hagatña will be completed and used to enter into the next phase of construction.
- Guam Historic Courthouse Restoration Planning Project-GPT will be actively Involved with the Architecture and Engineering design phase to restore the Guam Historic Courthouse.

ALLENGE

FUNDING for rehabilitation and restoration work will be GPT's greatest challenge in the year ahead. Enactment of PL33-66 reduced GPT's revenue source (DPW permit fees) by 50%. By this action GPT will be faced with limited funding for grants and projects.

Projects currently in queue include the rehabilitation of the FQ Sanchez facility, the repairs of Agana Cathedral Basilica Bell Tower, Rehabilitation of the George Flores House in the Historic District of Inalahan, Reconstruction of the Rosario House in Hagatna, Reconstruction of the Benny San Nicolas House in Inalahan, and the Jose Lujan House Repairs.
