AGENDA

1.0. CALL TO ORDER / ROLL CALL

Chairman Makio called the meeting to order at 3:12 p.m. and conducted roll call.

2.0. APPROVAL OF MINUTES (August 9, 2023, Meeting)

Motion

Chairman Makio opened the floor for discussion on the Minutes of August 9, 2023.

Zina Ruiz motioned to approve the minutes as read. Edwin Reyes seconded the motion.

Chairman Makio opened the floor for discussion.

Joe Quinata referenced agenda Item 5.2.a. Inalahan Baptist Church.

The Board approved funding the structural assessment for the Inalahan Baptist Church,

however, the Board did not state a formal motion.

Chairman Makio recommended to make the formal motion under Old Business.

With no further discussion, the Board unanimously approved the minutes of December 13, 2023.

Chairman Makio requested the Board recess the General Board meeting into Executive Session. With no objection, Chairman Makio recessed the General Board meeting and called for Executive Session.

The Board adjourned Execution Session and reconvened the General Board meeting at 3:53.

3.0 OLD BUSINESS

3.1. CNMI SHPO Request for Assistance - Rota Kombento

Joe Quinata reported no new update but will advise the Board of any new developments.

3.2. Inalahan Baptist Church - Bill 97-37

Joe Quinata reported the Legislature recently approved Bill 97-37, A act to authorize GovGuam to enter a MOA with the Inalahan Mayor and Inalahan for lot 106-1, Lot 12 in the municipality of Inalahan, formerly known as the Inalahan Baptist Church for the preservation of the Inalahan Baptist Church.

The passage of Bill 97-37 transfers the authority to the Inalahan Mayor therefore any discussion or efforts regarding the stabilization or rehabilitation of the Inalahan Baptist Church starts with the Mayor of Inalahan. The Inalahan Mayor may also take the position to demolish the building altogether if problematic.

Chairman Makio referred to the discussion during the review of the December 13, minutes and entertained a Board motion to ratify and approve to fund the Structural Assessment for the Inalahan Baptist Church.

Motion

Vince Leon Guerrero motioned to accept the proposal from Duenas Camacho and Associates to provide funding \$26,788.00 to conduct the structural assessment and stabilization effort for the Baptist Church. Zina Ruiz seconded the motion.

Chairman Makio opened the floor for discussion.

With no further discussion, the Board unanimously approved the motion.

Motion

Edwin Reyes motioned to add an agenda item under New Business, to include a discussion on collaborative opportunities to work with the Guam's SHPO's office to enhance the functions and protections of historic resources. Zina Ruiz seconded the motion.

With no discussion or objection, the Board unanimously approved the motion.

4.0. NEW BUSINESS

Collaborative Opportunities to work with the Guam's SHPO's office to Enhance the Functions and Protections of Historic Resources

Chairman Makio opened the floor to Edwin Reyes to launch the discussion on collaborative opportunities to work with the SHPO's office to enhance the functions and protection of historic resources.

Edwin Reyes suggested focusing on priority areas such as 1) historic resource protection; 2) where GPT's resources can assist to identify needs in legal or policy framework regarding historic preservation; 3) to support other SHPO offices.

The Board discussed the following:

- The role of the Historic Review Board in reviewing properties for listing in the local and National Register of Historic places, but not in review of legal or policy framework in historic preservation or operational functions of the SHPO.
- Funding of the SHPO's office by the Government of Guam.
- Collaborative effort of preservation stakeholders, the SHPO, and GPT to request the Office of the Attorney General to 1) promulgate rules regarding historic preservation and provide more legal support to the SHPO; 2) funding a part-time Attorney at the AG's office dedicated to the Historic Preservation office.

Patrick Lujan noted requests for additional funding has been submitted to the Guam Legislature for the department's operational needs. The SHPO's office is seeking support from all historic and cultural resource stakeholders to work in a collaborative effort to evaluate local, state, and federal laws in relation to overall historic preservation. The SHPO, GPT and the historic preservation community can review preservation laws and rewrite the law to enhance the protection of historic resources.

An example of stakeholder support in preservation is the Young Men's League of Guam and the I Naftan Mananai-Ta project and their involvement lobbying to adjust local statues. The more involved preservation entities and stakeholders express the need to make changes in protecting historic resources, the more it would bring the SHPO's office closer to resolving issues, especially in the areas of private property owner's rights.

Chairman Makio directed Joe Quinata to assemble an ad hoc committee consisting of Board members and other interested entities and stakeholders to prepare formal recommendations to build support of the SHPO's efforts.

Action

The Board requested the committee provide a report by the next Board meeting. Chairman Makio asked Edwin Reyes, who also accepted to Chair the ad hoc committee.

5.1. a. YTD Balance

Joe Quinata reported the current fund balance is \$6,048,755.59. The total obligated fund for Board approved projects and grants is \$5,977,691.44 leaving a remaining of \$71,064.15 for projects in queue.

GPT received \$200,000.00 from the collection of building permit fees.

The Board discussed defunding the following completed or closed Board initiatives.

The Archbishop Flores House - \$250,000,00

Joe Quinata reported the house showed a selling price of \$400,000 on a listing of the Archdiocese properties up for sale.

Chairman Makio strongly urged a more concerted effort to obtain more information before defunding the \$250,000 to purchase the house.

Joe Quinata reported GHURA has expressed an interest in purchasing the Archbishop House and the adjacent property which houses the Kamalin Karidat kitchen. GPT will be meeting with GHURA to discuss the possible use of the properties.

Chairman Makio requested to summarize the results of the GHURA meeting for presentation to the Board.

Edwin Reyes commended Joe Quinata for looking into the GHURA Block Grant program as an additional effort to acquire the property with a joint mission.

Vince Leon Guerrero expressed concerns of the Block Grant programs that have been unsuccessful and requested feedback on the limitations and guidelines of the grant program.

Joe Quinata will obtain more information from the Archdiocese regarding GPT's offer to purchase the property.

The Board did not approve defunding the \$250,000.00 until such a time that staff obtains more information on the property.

Atantano Archaeology Workshop \$2,500.00

GPT will not conduct the workshop at this time. Staff recommended defunding the amount of \$2,500.00.

Strategic Plan \$21.359.18

The staff completed the Strategic Plan and recommended defunding the amount of \$21,359.18. Staff will prepare a proposal for the Board's approval, if in the future GPT plans to

provide an update of the Plan to the stakeholders and the preservation community,

Architecture Book for Reprint \$314.00

The staff coordinated the reprint of the Architecture Book and copies are available at the GPT office. Staff recommended defunding the amount of \$314.00.

Archbishop Flores House Cleanup \$60.00

The Archbishop Flores cleanup project is completed. Staff recommended defunding the unused balance of \$60.00.

The Association of Chamorros in the Midwest \$1.000.00

The Association of Chamorros in the Midwest participated in the Fair however, the organization did not utilize the funds. The staff recommended defunding the amount of \$1,000.00.

Marianas History Conference \$5.604.01

GPT staff attended the Marianas History Conference. GPT did not expend the total appropriation for Board travel and staff recommended defunding the amount of \$5,604.01.
